 - 3. Currently, only 2 (ish) panels are reporting out. Supposed to be 3.4KW, and on a bright sunny day, nothing was reporting back
 - Steps- a) Have Larry Mauchly come look at it (\$250-\$500 per Sandra Jones), b) Have they been/do they need to be cleaned? James says even if they're dirty, they should have "low" output, not "no" output
 - 5. Where would this money come from? Becky-If it's not a lot, town would cover, if a lot, Trustees would need to kick in some
 - 6. Bill Bolton-Selectboard rep on Energy Commission, Maggie could check with him for financial help
 - 7. Most common thing to fail is inverters (\$7-10K/inverter, probably there are 2 of them)...usually 7 years out, but could be something less expensive, like connectors
 - 8. Energy Commission should be able to figure out finances
 - 9. James-We (Trustees) should fund the assessment, then reach out to the town to fund any repairs
 - 10. Joyce will be the contact person between Maggie and Trustees
